Dave discusses the testcases document:

POL_3001_TestCase (page 8)

Currently POL_3001 makes use of a Binding type in the WSDL that is actually proprietary to IBM

Anish: There is a standard non-SOAP HTTP binding available, which can be used for this purpose

Mike: Yes, the standard JDK 6 implementation of JAXWS supports that HTTP binding

ACTION 20100607-01 (Dave) Update the WSDL of POL_3001_TestCase to use the non-SOAP HTTP binding

2) POL_4024_TestCase

Both the test assertions for this testcase are marked "preferred" - what do we want to do with these?

Mike: For me "preferred" Test Assertions are not worth writing testcases for - since a failure may just be the result of not implementing optional function

Eric: How many "preferred" cases are there?

Dave: Not sure, perhaps a handful/

Dave: Ah, this actually looks like an error in the Test Assertions document - it says "preferred" when the spec statement has a "MUST"

ACTION 20100607-02 (Dave) Raise an issue against the Test Assertions document for those assertions marked with "preferred"

3) Point #12 in the Email: POL-TA-70001-70007 and POL-TA-80001-80004 and POL-TA-90003-90008, 90010-11, 90016-20, 90027-28 are marked as mandatory in the TA spec, but are marked as optional in the testcase document.

Dave: I believe the TA spec is wrong because none of the std intents have to supported.

EricW: "Preferred" = SHOULD "Permitted" = MAY - There do not seem to be any "Permitted" TA's

EricW: Maybe we only need an "Optional" = SHOULD or MAY if we are not going to write TC's for them?

Mike: I think that any of the features which are optional should not have testcases

ACTION 20100607-03: (Dave) Raise an issue to remove testcases for the TAs POL-TA-70001-70007 and POL-TA-80001-80004 and POL-TA-90003-90008, 90010-11, 90016-20, 90027-28 since they depend on optional function.

EricW: Would it be possible for the test suite to implement trivial functions for authroization/encryption/etc? Just for test purposes?

Mike: Eric - how would that work? on the SCA runtime side of things, that is...

4) Point #13 - 9019 introduces an interesting precedent in the test cases in that it handles runtimes which might throw up an error for 9006 regarding the lack of a policySet to provide the transactedOneWay and managedTransaction

Mike: This is an example where 2 intents can be examined statically and the error detected without running anything
