

NON-EXCLUSIVE LICENSE FOR STIX, TAXII, AND CybOX (AGREEMENT)

DHS License No: DHS–NPPD-1-2015

The National Protection and Programs Directorate of the Department of Homeland Security, Science and Technology Directorate, located at 245 Murray Lane, Washington, D.C. 20528, (DHS) under the terms below licenses the Organization for the Advancement of Structured Information Standards, located at 35 Corporate Drive, Suite 150, Burlington, Massachusetts 01803 (OASIS or LICENSEE or RECIPIENT), to three suites of cybersecurity standards, STIX, TAXII, and CybOX (STANDARDS SUITES).

BACKGROUND. The Department of Homeland Security has, over time, developed or has had developed three cybersecurity STANDARDS SUITES: (1) Structured Threat Information eXpression (STIX), a collaborative community-driven effort to define and develop a standardized language to represent structured cyber threat information; (2) Trusted Automated eXchange of Indicator Information (TAXII), the main transport mechanism for cyber threat information represented as STIX; and (3) Cyber Observable eXpression (CybOX), a standardized schema for the specification, capture, characterization, and communication of events or stateful properties that are observable in the operational domain.

DHS owns the copyright and trademark to each of those STANDARDS SUITES and desires to make these STANDARDS SUITES available to the maximum extent possible to enhance cybersecurity for all users. OASIS provides a forum for the dissemination and further enhancements to those STANDARDS SUITES to accomplish that purpose. DHS does not currently own any invention and has not applied for any patent associated with the STANDARDS SUITES. Should any patent arise from DHS’s contracting for any of those STANDARDS SUITES, DHS would have “a nonexclusive, nontransferable, irrevocable, paid-up license to practice, or have practiced for or on its behalf, the subject invention throughout the world.”

1. Terms of Software Usage Agreement. For good and sufficient consideration, the parties agree as follows:

2. Definition.

(a) DHS grants LICENSEE a perpetual, irrevocable, non-exclusive, royalty-free, worldwide copyright license, with the right to sublicense to copy, publish, and distribute the STANDARDS SUITES in any way, to prepare derivative works that are based on or incorporate all or part of the STANDARDS SUITES solely for the purpose of developing and promoting cybersecurity and enabling the use of any of the STANDARDS SUITES or derivative products by sublicensees or other users (PURPOSE).

(b) LICENSEE shall cause any sublicensee or other user to be bound to the terms of this LICENSE.

(c) The STANDARDS SUITES and documentation provided are subject to a copyright in the United States Government. A portion of the STANDARDS SUITES and documentation may be subject to a copyright in a third party. RECIPIENT shall assure that any copies of the SOFTWARE or documentation, in whole or in part, are marked:

3. **Denial of Additional Licenses and Reservation of Trademark.** (a) This LICENSE does not, in any manner, constitute an exclusive release of the STANDARDS SUITES to LICENSEE. DHS may distribute the STANDARDS SUITE to any other entities under such terms as it deems appropriate.

(b) This LICENSE does not, in any manner, constitute an endorsement by DHS of any test results, resulting designs, hardware, or any application resulting from LICENSEE's use of the STANDARDS SUITE, including accompanying documentation.

(c) DHS, on behalf of the United States Government, asserts its common law trademark in "STIX," "TAXII," "CyBOX," any related mark, and any associated graphic identity. RECIPIENT shall, in recognition of DHS's interest, include "TM" in any written reference to this STANDARDS SUITES and shall, upon direction of DHS, substitute "®".

(d) LICENSEE is licensed to use the names and trademarks for the STANDARDS SUITES in the form provided by DHS, any later versions that may be provided by DHS, and derivatives made by OASIS as permitted under this LICENSE to accomplish the PURPOSE pursuant to OASIS's technical process. The names and trademarks for the STANDARDS SUITES may not be used in association with commercial products.

(e) With regard to any derivative work based upon the STANDARDS SUITES or their component parts, LICENSEE shall acknowledge that the United States owns the copyright and trademarks and provided them under license to LICENSEE.

(f) RECIPIENT shall not apply for registration of any trademark or service mark or assert any common law mark related to the STANDARDS SUITE or accompanying documentation, without the prior written permission of DHS.

4. **Applicable Law.** This LICENSE shall be construed, and the legal relations between the parties hereto shall be determined, in accordance with United States Federal law.

5. **Entirety of Agreement.** This LICENSE constitutes the entire understanding and agreement between the parties hereto relating to access to the STANDARDS SUITE by LICENSEE and may not be superseded, modified, or amended except by further written agreement duly executed by the parties.

6. **Disclaimer of Liability.** (a) The United States Government shall be not be liable or responsible for any maintenance or updating of the provided STANDARDS SUITES, nor for correction of any errors in the STANDARDS SUITES.

(b) LICENSEE will make the STANDARDS SUITE and any component parts or derivatives available for its use and any sublicensees or others only subject to the following disclaimer of liability:

STIX, TAXII, AND CybOX (STANDARD OR STANDARDS) AND THEIR COMPONENT PARTS ARE PROVIDED "AS IS" WITHOUT ANY WARRANTY OF ANY KIND, EITHER EXPRESSED, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTY THAT THESE STANDARDS OR ANY OF THEIR COMPONENT PARTS WILL CONFORM TO SPECIFICATIONS, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR FREEDOM FROM INFRINGEMENT, ANY WARRANTY THAT THE STANDARDS OR THEIR COMPONENT PARTS WILL BE ERROR FREE, OR ANY WARRANTY THAT THE DOCUMENTATION, IF PROVIDED, WILL CONFORM TO THE STANDARDS OR THEIR COMPONENT PARTS. IN NO EVENT SHALL THE UNITED STATES GOVERNMENT OR ITS CONTRACTORS OR SUBCONTRACTORS BE LIABLE FOR ANY DAMAGES, INCLUDING, BUT NOT LIMITED TO, DIRECT, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES, ARISING OUT OF, RESULTING FROM, OR IN ANY WAY CONNECTED WITH THESE STANDARDS OR THEIR COMPONENT PARTS OR ANY PROVIDED DOCUMENTATION, WHETHER OR NOT BASED UPON WARRANTY, CONTRACT, TORT, OR OTHERWISE, WHETHER OR NOT INJURY WAS SUSTAINED BY PERSONS OR PROPERTY OR OTHERWISE, AND WHETHER OR NOT LOSS WAS SUSTAINED FROM, OR AROSE OUT OF THE RESULTS OF, OR USE OF, THE STANDARDS, THEIR COMPONENT PARTS, AND ANY PROVIDED DOCUMENTATION. THE UNITED STATES GOVERNMENT DISCLAIMS ALL WARRANTIES AND LIABILITIES REGARDING THE STANDARDS OR THEIR COMPONENT PARTS ATTRIBUTABLE TO ANY THIRD PARTY, IF PRESENT IN THE STANDARDS OR THEIR COMPONENT PARTS AND DISTRIBUTES IT OR THEM "AS IS."

(c) The disclaimer of liability recited in paragraph 6(b) may appear in conjunction with a similar disclaimer for LICENSEE. Those disclaimers of liability may be joined and the DHS disclaimer of liability of paragraph 6(b) may be synopsisized to conform to size limitations of portions of the STANDARDS SUITES with the prior, written approval of DHS.

7. **Effective Date and Duration.** (a) The effective date of this LICENSE shall be the date of LICENSEE's execution of this LICENSE as set forth below.

(b) From time to time, DHS or its contractor may provide LICENSEE with a later version of STANDARDS SUITES. All of LICENSEE's duties under this LICENSE shall apply, as well, to the later version(s).
