- Does the JSON CSAF document capture product information, or are references via CPE/SWID/SPDX sufficient?
- Conclusion from the call: "yes, store product information in JSON". Scenarios that make this essential when it is useful to have textual descriptions available for products for human consumption, in addition to CPE/SWID/SPDX.
- Additionally, when a report wants to capture additional information about a product that isn't relevant to CPE/SWID/SPDX, such as platform / architecture / vendor attributes.
- Also when SWID/SPDX/CPE might not yet exist (brief aside - we were unable to identify on the call how to even register a CPE for a product).
- Open source projects may never dedicate the resources to properly identify their artifacts with any particular standard.
- How should the JSON capture and refer to the product information in the JSON file?
- Eric followed up followed up over email to the TC mailing list detailed discussion on these fields/suggestions/questions.
- Feng Cao suggested several things to consider when designing the "version" fields in JSON and followed up over email to the TC mailing list with additional details.
