TERMS & CONDITIONS

The following Terms and Conditions apply specifically to the OASIS Borderless Cyber & FIRST Technical Symposium ('EVENT') to be held in December 2017 in Prague, Czech Republic. Sponsorships are granted on a first-come, first-served basis. FIRST.Org reserves the right to reject any Sponsor that it deems inappropriate. 'Sponsor' includes any person, firm, or company, corporation, institution, association or committee to whom the sponsorship is allocated. 'Venue' refers to the location where the event is being held.

1. All sponsorships will be awarded on a first come, first-served basis. FIRST.Org retains the right to reject any sponsor that it deems inappropriate.
2. After written acceptance by FIRST.Org, the sponsor must provide a signed copy of the sponsorship form, sponsorship funds, logo image (in .AI or .EPS, the format required by FIRST.Org) and other details required (such as correct use of the sponsor's name, trademarks etc.) to FIRST.Org, within 15 business days of receipt of acceptance.
3. Sponsorship agreements cannot be processed without payment. Funds must be payable in US dollars. All checks should be made payable to the FIRST.Org. Sponsor shall be responsible for any taxes on the sponsorship fee. For more information, contact events@first.org.
4. Sponsorship may be cancelled by sponsor by written notification to FIRST.Org before 1 October 2017. A sponsorship cannot be cancelled after that date because FIRST.Org incurs the cost of printing and other sponsorship recognition and loss of sponsorship. If notification of cancellation is received after 1 October 2017, FIRST.Org will attempt to revise sponsor recognition items as feasible and FIRST.Org shall be entitled to retain 100% of the sponsorship fee as damages.
5. The sponsorship fee does not include free EVENT registration unless specifically stated in the sponsorship opportunity details.
6. Provision of EVENT sponsorship does not entitle the sponsor to a waiver of any applicable annual membership fee.
7. Accommodation costs are not included in the EVENT registration fee.
8. All sponsorship materials must be submitted before 1 October 2017 to ensure inclusion in productions schedule. Sponsorship pledges after this date may still be accepted with caveats.
